The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

Car No: 51 Driver: VAYA, FILIP

Facts:

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of 53.9 km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement
- Other

Offence:

- Breach of Article 34.11 of the GT4 Europe Sporting Regulations
- Breach of Article of the FIA International Sporting Code

Decision:

- Fine 200 Euros
