The Stewards, having received a report of the Technical Delegate, have considered the following matter, determine the following:

Session: Before Free Practise

Fact: Replacement tyre(s) required due to Damaged Carry-over Tyre(s) from Previous Competition

Offence: Breach of Article 29.10 of the GT4 European Series Sporting Regulations

The above competitor explained to the Tyre manufacturer that a specified number of tyres of the S1 (carry-over tyres from previous competition) are damaged and they request for replacement tyre(s), the damage & subsequent request was confirmed by a report from the Tyre Manufacturer & Technical Delegate.

In order to enable the Competitor to continue to take part in the Competition the Stewards approve the request as per above decision, taken in consideration this is before Free Practise and consider this as force majeure.
