The Stewards notify the following:

(1) Balance of Performance:

In accordance with Article 30.1 of the 2024 GT4 European Series Sporting Regulations, the Stewards confirm that the Balance of Performance document applicable for this competition is the document;

bearing the header:

BALANCE OF PERFORMANCE FOR JEDDAH

and the title:

BALANCE OF PERFORMANCE SRO GT4 CARS

and identified by the footer:

(2) Pit Lane Delta / Minimum Pit Stop Times:

In accordance with article 20.2 of the 2024 GT4 European Series Sporting Regulations the Pit Lane Delta for this event is defined as 24 seconds. The minimum pit stop time for the mandatory pit stop with driver change only, will be 74 seconds.

In accordance with Article 20.2 of the 2024 GT4 European Series Sporting Regulations, its determined in case of a change of weather/adherence

- the mandatory pit stop time to change all 4 tyres from Dry to Wet or Wet to Dry will be minimum 3 minutes (180 seconds) from pit in to pit out.
- Any other pit stop (outside the mandatory pit stop) to change all 4 tyres from Dry to Wet or Wet to Dry will be minimum 2 minutes plus the Pit Lane Delta, which for this event equates to 2 minutes 24 seconds (144 seconds) from pit in to pit out.

(3) Conversion of Drive-Through and Stop & Go Penalties:

In accordance with Article 16.5 of the 2024 GT4 European Series Sporting Regulations the time penalty to be applied is;

30 seconds in the case of a Drive-Through Penalty, and

35 seconds plus prescribed stop time in the case of the Stop & Go Penalty

(4) TV Production company Representatives Access to Parc Fermé:

The Stewards confirm that, subject to approval by the Officials responsible for supervision of Pare Fermé at the relevant time, the following representatives of the official TV production company are permitted to enter Pare Fermé:














(5) Total Energies / Elf Representatives Access to Parc Fermé:
