The Stewards notify those concerned of the following:

Conversion of Drive-Through and Stop-and-Go Penalties to Time Penalties:

In accordance with Article 16.5 of the GT4 European Series powered by Rafa Racing Club Sporting Regulations 2025, the time penalty which will be applied in the case of any drive-through or stop-and-go penalty notified close to the end, or after, the race at this competition will be as follows:

Drive-Through Penalty: will be converted to **45** seconds added to the elapsed time of the car.

Stop-and-Go Penalty: will be converted to **50** seconds plus the prescribed stop time added to the elapsed time of the car.

Mandatory Pit-Stop time:

Mandatory pit-stop time: **95 seconds.**

Tyres change during mandatory pit stop or out of the window: **165 seconds.**

Driver catégorisation dérogation confirmation:

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #99 Cindy GUDET as Bronze only for the Misano round of the GT4 European Series powered by Rafa Racing Club to compete with MATMUT EVOLUTION in the PRO-AM category with Gabriela JILKOVA (Silver).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #20 Lucas SUGLIANO as Bronze only for the Misano round of the GT4 European Series powered by Rafa Racing Club to compete with CHAZEL Technologie Course in the PRO-AM category with Lucas CARTELLE (Silver).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #24 Nico FERRARIN as Bronze only for the Misano round of the GT4 European Series powered by Rafa Racing Club to compete with JSB Competition in the PRO-AM category with Viny BELTRAMELLI (Silver).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #27 Alessandro TUDISCA as Bronze only for the Misano round of the GT4 European Series powered by Rafa Racing Club to compete with AV RACING in the PRO-AM category with Lorenzo DONNIACUO (Silver).

Permission granted to drive alone:

The Stewards confirm the permission given by the SRO Sporting Board to the driver of car #28 AV RACING – driver Aijth KUMAR to race alone in Races 7 & 8 at Misano on 19th - 20th June 2025.

It is a condition that the driver must vacate and then re-enter the car during the compulsory pitstop in the races.

Clarification on Article 29 of the 2025 SR of GT4 European Series:

The Stewards notify those concerned of the following clarification on article 29 of the 2025 Sporting Regulations of the GT4 European Series powered by Rafa Racing Club:

29.1 A new tyre is a tyre that has not been previously registered and/or allocated to a car. A set of tyres must comprise two front tyres and two rear tyres. Front and rear tyres are not interchangeable.

*29.10 In case of a puncture or other damage during Qualifying or Race, another **used** tyre from those registered for the Competition may be used to replace it. This replacement must be notified to the Technical Scrutineers. **Note that in this case, the rules on interchangeable tyres do not apply and any used tyre may be used.***

Balance of Performance:

In accordance with Article 30.1 of the Fanatec GT4 European Series powered by Rafa Racing Club Regulations 2025, the Stewards confirm that the Balance of Performance document applicable for this competition is the document bearing the header:

“BALANCE OF PERFORMANCE FOR MISANO”

and the title: **“BALANCE OF PERFORMANCE SRO GT4 CARS”**

and identified by the footer: **“Decisions taken by the SRO GT Bureau 11/07/2025”**
