The Stewards notify those concerned of the following:

Conversion of Drive-Through and Stop-and-Go Penalties to Time Penalties:

In accordance with Article 16.5 of the GT4 European Series powered by Rafa Racing Club Sporting Regulations 2025, the time penalty which will be applied in the case of any drive-through or stop-and-go penalty notified close to the end, or after, the race at this competition will be as follows:

Drive-Through Penalty: will be converted to **26** seconds added to the elapsed time of the car.

Stop-and-Go Penalty: will be converted to **31** seconds plus the prescribed stop time added to the elapsed time of the car.

Mandatory Pit-Stop time:

Mandatory pit-stop time: **76 seconds.**

Tyres change during mandatory pit stop or out of the window: **146 seconds.**

Driver catégorisation dérogation confirmation:

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #99 Cindy GUDET as Bronze only for the Barcelona round of the GT4 European Series powered by Rafa Racing Club to compete with MATMUT EVOLUTION in the PRO-AM category with Gabriela JILKOVA (Silver).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #24 Nico FERRARIN as Bronze only for the Barcelona round of the GT4 European Series powered by Rafa Racing Club to compete with JSB Competition in the PRO-AM category with Viny BELTRAMELLI (Silver).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #27 Maximilien HUBER as Bronze only for the Barcelona round of the GT4 European Series powered by Rafa Racing Club to compete with AV RACING in the PRO-AM category with Arthur RASSE (Bronze).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #16 Brandon OXLEY as Bronze only for the Barcelona round of the GT4 European Series powered by Rafa Racing Club to compete with NM RACING TEAM in the PRO-AM category with Marc DE FULGENCIO (Silver).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #77 Ali JUFFALI as Bronze only for the Barcelona round of the GT4 European Series powered by Rafa Racing Club to compete with ELITE MOTORSPORT WITH ENTIRE RACING ENGINEERING in the AM category with Reema JUFFALI (Bronze).

The Stewards confirm the driver categorisation derogation given by the SRO Sporting Board to the driver #31 Ismaeel ELLAHI as Bronze only for the Barcelona round of the GT4 European Series powered by Rafa Racing Club to compete with W&S MOTORSPORT in the AM category with Tim HORRELL (Bronze).

Clarification on Article 29 of the 2025 SR of GT4 European Series:

The Stewards notify those concerned of the following clarification on article 29 of the 2025 Sporting Regulations of the GT4 European Series powered by Rafa Racing Club:

29.1 A new tyre is a tyre that has not been previously registered and/or allocated to a car. A set of tyres must comprise two front tyres and two rear tyres. Front and rear tyres are not interchangeable.

*29.10 In case of a puncture or other damage during Qualifying or Race, another **used** tyre from those registered for the Competition may be used to replace it. This replacement must be notified to the Technical Scrutineers. **Note that in this case, the rules on interchangeable tyres do not apply and any used tyre may be used.***

Clarification on Article 29.10 of the 2025 SR of GT4 European Series (Tyre Limitations for Dry-Weather Tyres)

From the second Competition onwards for full-season Competitors and for returning race-by-race Competitors, a maximum of three sets of new tyres (S2, S3, S4) as well as a maximum of one set of used tyres from a previous Event (S1) which can be used in Free Practice **and/or Pre-Qualifying** only.

Balance of Performance:

In accordance with Article 30.1 of the Fanatec GT4 European Series powered by Rafa Racing Club Regulations 2025, the Stewards confirm that the Balance of Performance document applicable for this competition is the document bearing the header:
