Facts:

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of \_\_\_\_\_ km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement .....

- Breach of Article 33.4 and 33.10 of the GT4 European Series Sporting Regulations
- Breach of Article 2. c of the FIA International Sporting Code opp 4 - chop. 4.
