The Stewards, having received a request from the competitor and, having heard from the competitor's representative, have considered the following matter and determine the following:

**No. / Driver:** 222 / Rodolphe Wallgren and Gael Castelli  
**Competitor:** Mirage Racing – Entrant: Rodolphe Wallgren  
**Time (fact):** 10:00 hrs  
**Session:** Practice 1 & 2  
**Fact:** The competitor does not possess, nor can he acquire part-worn tyres from a SRO GT4 Europe test session to use in the practice sessions at this event.  
**Offence:** Breach of Article 30.3 of the GT4 European Series Sporting Regulations  
**Decision:** **Use of 1 set of part-worn tyres from a previous FFSA GT4 session is permitted for practice 1 & 2 only.**  
**Reason:** Article 29.3 of the GT4 European Series Sporting Regulations defines under description S2, a competitor may use a used set of tyres from a previous official test session in Free Practice 1 and 2 only. Article 30.3 clarifies that tyres from other SRO-promoted GT4 series may only be used in the Official Paid Test Sessions but may not be carried over into the event, i.e. into Free Practice 1 and 2.  
The competitor gained a late entry for car 222, only a few days before this event; this car has not competed in the GT4 European Series at any previous event in 2021. Pirelli were able to supply the prescribed number of new sets of tyres but were unable to provide any part-worn tyres in accordance with the regulations.  
The competitor seeks to participate in Free Practice 1 and 2 using one set of new tyres and seeks permission to use 1 set of part-worn tyres from a previous FFSA GT4 session. The Stewards, noting the requirements of the regulations also take into consideration the fact that the official tyre supplier was, due to the short notice, unable to provide any part-worn tyres compliant with the regulations. The Stewards therefore grant dispensation, for this event only and specifically for Free Practice 1 and 2 for the Mirage team to use the 1 set of part-worn tyres for car 222.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code, within the applicable time limits.
